endorsed Solomon Kinloch, Jr. for Mayor of the City of Detroit. This is a major endorsement!

The membership chose someone with a proven track record of taking care of the people. Candidate Kinloch's story is very intriguing. He built a church of 40 people into a system of churches with 40,000

members. He serves the community, well.

As a member of UAW Local 235, Kinloch understands our values and solidarity. He was a big help to our striking members of Local 900 during the "Stand Up" strike. He delivered food to the picket lines and made sure our striking members were fed during a time when they needed it the most.

Introducing the Trust HRA (Health Reimbursement Arrangement)

Most Common Eligible Expenses:

- MEDICAL Ambulance services, chiropractic adjustments. Coinsurance, copays, hearing aids, lab fees, deductibles, prescription drug copays
- DENTAL Cleanings, coinsurance, copays, crowns, dentures, denture adhesives and cleaners, fillings and orthodontics
- VISION Prescription glasses and sunglasses, contact lenses, contact solutions and cleaning products, eye exams, eye drops, refractions, vision correction procedures (e.g. Lasik) and vision screenings
- PREMIUMS Medicare Part A, B, and/or D premiums or IRMAA payments (Members must submit for reimbursement – cannot use the WEX debit card.)

Members have \$600 available for 2025

How the Card Works:

- Swipe card to instantly pay for eligible expenses.
 Card runs as a credit. It works at qualified medical, dental, vision, and pharmacy locations and retail locations that offer point-of-sale transactions.
- Keep your Debit Card, it will be reloaded every January 1st. Keep all WEX material sent to you.

Bill To Exempt MICHIGAN SENIORS From Paying Property Taxes

Senate Bill 292, would amend the state's General Property Tax Act by adding Section 7yy. This bill exempts Michigan residents age 70 or older from paying property taxes on their primary residence, effective for taxes levied after December 31, 2025.

To qualify for the exemption under SB 292, an individual must:

- Be 70 years of age or older
- Own and occupy the home as their primary residence
- File a claim with a local assessor, along with documentation verifying their age and residency

If SB 292 becomes law, it could offer financial relief to thousands of households, particularly in fixed-income or retirement situations.

The bill must clear the Senate committee before heading to the floor for a vote. If passed, it would then move to the Michigan House and potentially to Governor Whitmer's desk.

The bill was introduced by Sen. Michele Hoitenga (R-Manton). Contact her or your state Senator if you support this bill.





Again, be safe, have a great summer, and we look forward to seeing you in September.


Strength In Unity...

In my last article, I said regarding the Presidency of our country that I thought it was best to take a wait-and-see attitude towards President Trump's second term. So far, in the first 100 days, we have seen a lot of market volatility as a response to a good deal of changes in the President's tariff changes. The USA Bond rating has been downgraded and many former investors are now moving their investment dollars to other countries. The stock market volatility, the frequent changes in tariffs, investors choosing not to invest in the United States has contributed to a shrinking of our economy. For now, it is a small amount and may not shrink any further. All of which to say at this point, while the first 100 days have appeared chaotic, it is still too soon to render a firm declaration of what to expect on our economy.

However, on the subject of deportation of immigrants, what is abundantly clear is several federal courts have all ordered President Trump and the

U.S. Department of Justice to stop the deportations, return those already deported, and allow them access to the U.S. guarantee of due process.

As of 5-21-25, President Trump and the Justice Department have refused to comply with this order. And, now one of the Federal Judges announced that if compliance is not forthcoming the judge may pursue criminal contempt charges against the persons refusing to comply. This could actually result in criminal charges being filed against the attorneys, which presents a serious threat to an attorney's ability to practice law.

So, I will be watching closely to see what happens both with our economy and the issue of Federal criminal contempt charges.

Basic Information About HRA WEX

In April, the UAW Medical Trust mailed a packet of material to every eligible member. It described the new Healthcare Reimbursement Arrangement (HRA) and the WEX debit cards that we would receive. Please keep this mailing, and others that you receive regarding the HRA

building on Plymouth Road in Livonia, starting at 1:00 p.m. Come out and make your voice heard – no cuts, no closings, no reduction in services.

The Republican Party response has been lame. Republican caucuses in the House and Senate have proposed massive cuts in spending, from Medicaid, school and nutrition programs, and programs that keep all Americans safe. All of these cuts will pay for massive tax cuts for billionaires, plus add billions, even trillions to the federal deficit.

When we protest the cuts to the Social Security Administration, Medicaid and Medicare, the lame response is "Nobody's benefits will be reduced." Consider this, if you have a bank that closes branches, quits phone services, and forces you to do all your banking online, is that a cut?

A reduction in services is a reduction in benefits. And never forget, S.S.A. is paid entirely out of the Social Security Trust Fund, a fund separate from the Treasury. We have paid for these benefits all of our working lives. It is our money that pays for these services, as well as our

WEX benefits.

Based on feedback from members, it is important to keep this in mind:

- A WEX card has a value of \$600. This \$600 is per household, not per individual.
- WEX cards are not interchangeable with OTC cards.
- WEX debit cards can be used to pay co-pays at doctor, dentist, or vision care office.
- · The claim forms that were included in the HRA packet are to be used to request reimbursements, or direct deposit reimbursements to your bank account.
- Keep receipts for health care expenditures you plan to seek reimbursement for.
- If you have received your WEX cards, activate them.

Details are spelled out in the booklet. If you have any questions, call the WEX toll free number at (844) 440-4300.

Thanks to Aletha Smith and Director Dickerson for the invitation. It was inspiring to hear all the other women's thoughts, experiences, and goals.

As some of you know, I am the guardian of

my 4-year-old granddaughter, Ava. Ava lost her mother in 2021, just two weeks before her first birthday. Ava, like one third of *all* American kids, is on Medicaid. Ava has autism, and is in therapy that Medicaid pays for. Ava, like other kids, desperately needs this therapy to learn coping skills and to sometimes talk.

The current majority of the U.S. House of Representatives and the Senate has a bill concerning Medicaid that will eliminate billions of dollars for medical services by cutting what is sent to the states.

My 88-year-old mother has Medicaid also, in a different state. So, states will then decide what little money is sent, pushing the blame on our states and not where the fault lies. That, dear friend, is in the lap of the Republicans in charge.

Wait for it. They want to reduce the number of people who are eligible for Medicaid by requiring them to work! How's a 4-year-old going to work?

I'm not going back to work after 50 years of paying in! Medicaid has some income restrictions already. So, who do we cut? My 88-year-old Mom, or the 4-year-old autistic child?

The UAW negotiated a decent retirement for me, but there is no way I'd be able to pay the bill for either of them, even though I'd do anything for them. Good afternoon to all Retirees of Region 1A, Summer is here! It's time to take off the coats and put out the flowers.

Keep all your detailed receipts, not just your credit card receipts, because they won't contain all the required information.

Heads Up

For HRA, you can't use your card for:

- 1. Groceries
- 2. Discount Programs
- 3. Assisted Living and Nursing Home Costs
- 4. Physician or Hospital Concierge fee
- 5. Costs that aren't considered qualified medical expenses as defined by the I.R.S.

The amount of the card's value is \$600. This is what you can use your card for:

realize that it could be dissolved at any moment.

I have met many Union members who can't afford their co-pays and deductibles. As a UAW member, I advocate for a Single-Payer plan that Walter Ruether knew would help to bring about a just society. I have experienced the death of my mother, who used cancer-causing powder by Johnson & Johnson (they kept it a secret). Another woman who lost her job and was waiting to get Medicare at 65, died of cancer. If she had medical care early, a hysterectomy could have saved her life. I could fill this paper with examples. Our UAW Union stands for unity, for the common good of all.

Do We Stay The Same?

Region 1A had an endorsement for Mayor of

the City of Detroit. One candidate brought up their plan for the city. It was almost identical to Bennie Napoleon's of 12 years ago. Benny made it clear that healthcare was an issue because people did not get proper medicines and many police runs were wasted on people having medical emergencies, both physical and psychological.

Next, he said we need to deal with people not having a safe place to live. He then pointed out that the educational system needed work to be done, to increase participation in full educational opportunities, and good jobs that paid good wages. We cannot expect people to live in poverty and expect a good balance in the society.

And last, he noted if you got these first four done, policing would be very easy. These points need action. Detroit's largest budget item is policing and protection. So, things in the city of Detroit have stayed the same except for the downtown and choice areas.

The UAW had a candidate endorsement for mayor of Detroit who is not the same and will not stay the same. This candidate does things differently. He is concerned about all the people who live in the city of Detroit. He comes with years of knowledge on how to help the neediest among us and leaving no man or women behind.

He wants to build on resources that are not connected to corporations that get tax credits, and don't deliver on their promises to help the citizens. Real solutions must come from those who do not expect to bleed the city for their own personal profit.

Stay the same or vote for change.

The last thing I would like to address is to point out a pattern with President Trump. President Trump ordered pharmaceutical companies to lower prices to match what they sell in other countries. The President entered a similar order which was taken up in court during his last Administration. Oh, it sounds good that he will have the pharmaceutical companies charge Americans the same as other countries. It makes us feel good.

But it will be challenged in court again and President Trump will blame the courts for not delivering to the American people reduced prescription costs. If he really wanted to change the pricing of drugs in this country, he should go to his Republican-controlled House and Senate and have them construct a bill that would allow the Secretary of Human Services, Medicare and Medicaid to negotiate prices and pattern the bill after the same bill that allows the Veterans Administration to negotiate the purchase of drugs.

President Trump's attempts will be challenged in court and he will blame the courts for what happens instead of following proper procedures to achieve the goal he stated. The powerful drug companies are not worried.

One must wonder, does the President really want to change or is this another way to stay the same?

Hope the summer is good to you. Looking forward to seeing you at the *Retiree Picnic* in August.


BLACK LAKE RETIREE RETREAT

'Scrap the Cap' on Benefits

Here we are on the verge of summer. That means that the Chapter will suspend meetings for the months of June, July and August 2025. Monthly meetings will resume on September 8th.

The Local, in an attempt to disseminate information in a more timely manner to retirees, is attempting to set up a hotline. Stay tuned for an update.

The "Scrap the Cap" on defined benefits for retirees is still in play. As a retiree, you should be contacting your Michigan Senator and Representative and urge them to introduce legislation to remove the \$300 annual cap on pension payments for members in the defined benefit program. The \$300 cap was established in 1987 with no index to inflation.

The following "Scrap the Cap" information (as of 4/2025) is from State Employee Retirees Association (SERA) by Mary Pollock.

"SCRAP THE CAP" UPDATE

SERA has received the 16-page, data-intensive Actuarial Study of proposed improvements in the 3 percent or \$300 cap on the annual cost-ofliving adjustments (COLA) for defined benefit (DB) State retirees and beneficiaries. The cap was adopted in 1987 and has never changed in the 38 years since. Inflation has been 176.1 percent since that time and over 85 percent of DB State employee retirees are at the \$300 cap.

According to a retired economist for the State who looked at the study, the average state DB retiree could see a change in their projected 2026 annual COLA to an amount between \$400 and \$738, depending on which option lawmakers

timely adopt for inclusion in the current Fiscal Year 2026 budget.

Background – Recall that Public Act 121 of 2024, the Fiscal Year 24-25 General Omnibus Appropriations law sponsored by State Senator Sarah Anthony (D-Lansing) contained a provision providing for an actuarial study of three options:

- 1. Replacement of the current 3% or \$300 cap with a cost-of-living adjustment based on the Consumer Price Index for Americans 62 years of age or older.
- 2. Replacement of the \$300 cap with \$808 adjusted annually according to the Consumer Price Index for Americans 62 years of age or
- 3. Replacement of the 3% or \$300 cap with a 4% or \$400 cap.

Caveats for the study included:

- b. That the COLAs made to a retiree's compensation after retirement and before the prospective change remain unchanged.
- c. That the proposed COLA changes are applied to the retiree's base pension amount excluding previous COLAs.
- d. The actuary must include in the study an estimate of the number of individuals impacted under each proposal.
- e. The actuary must include in the study an analysis of a 30-year projection of costs to the State to implement the proposals described in subsection.
- f. The inflation factor built into Option 1 and 2 defy accurate projection. The study used 2.45%.

The study was based on workforce and retiree data of September 30, 2023, the latest available for the study.

SERA representatives will be meeting with the Office of Retirement Services and others to understand better all the provisions and implications in the study. If a way forward is seen, a bill to change the State Employee Retirement Act would need to be created and introduced, and the appropriation bill for FY 2026 would need to include the necessary dollars to fund it.

SERA is a coalition member working with retiree chapters in an attempt to have the \$300 annual cap removed and go with a payment that reflects the economic reality of today.





The scholarship papers are our High School Seniors (Region 1A) sharing their insights into this country's function. There were a number of papers that noted the unequal treatment in health care. It was clear to many of the students that profit was more important than the patient in our United States system.

Other leading nations
have some type of control
on profits and demand that
tax and premium dollars be
placed in a trust of various types,
for single-purpose healthcare. That
money can be spent on healthcare needs
with controlled management costs, and no
profit for the stock market.

Some of the papers noted that if everyone had health care there would be a more tranquil society, people could work without fear of going to the doctor and having huge bills. You would not have to stay on a job, because of health insurance.

They also noted the productivity rate would increase. They noted the poor would feel part of the society, and would respond in kind. The most important thing that they pointed out is that even though it would cost money in the beginning it would benefit us

in healthcare outcomes and increase life expectancy. It would *cost less in dollars* when people received equal care based on need not insurance calculations. Therefore ER visits would decline, avoidable illness reduced, and medications would be taken without fear of cost. The patient would be able to follow their chemotherapy, and medical debt would end.
